## Robin Glover

Hi my name is Robin Glover; I am an Alum of the district and parent. I am here again today to voice my concerns over the achievement gap for black students. To be frank and honest, we are failing black children in our community. I would like to highlight a few data points that stand out to me, 79% of our black student do not meet proficiency standards in language arts and 86% in math. This is the type of problem we need to solve for our teachers and parents. We need everyone to come together in the community. I ask that we create a comprehensive plan that everyone review much like we have done with the Portrait. This demands our full attention and resources. I am asking for this body to act. I want to be part of the solution. I am ready to get to work to help us get there.

### Candace Ward

I am Candace Ward, me and my kids been in the district a few years now, I came here a little less than a year ago practically begging for someone to hold Amy Jefferson accountable for the way that her and Felicia Starks have been treating me and my kids. I have a few points I would like to touch on that made the most traumatic impact on my family. Back in May 2022 I had the police called on me at Longfellow saying I was threatening. They called the police and 911 told the principal the situation did not require

police presence. Another situation with the former assistant principal, Faith Harris, who gave my daughter an in-school suspension that I was not informed about, they had her closed off in a room that was not a designated room. I expressed my concerns to be totally transparent, I was aggressive by the time I heard what had happened. I was having concerns and issues every other month. I was led to believe that Dr. Starks was going to handle this problem. She never handled the problem, I was instead issued a notrespassing notice and told to provide 48hrs notice to come to the school that my children attend.

### Middle School Student

Correct me if I am wrong, but all of you appear to be adults. Do me a favor and think back to 5<sup>th</sup> grade. Imagine being locked in a room or small space by your principal and assistant principal all because they don't like the way your mom handled them. Mind you she speaking out of anger because she expects better from someone with degrees, acting as the leader of a school. Imagine the school nurse telling you they our of pads but she will stick a tampon in your vagina in 5<sup>th</sup> grade. I know that is inappropriate. Dr. Starks was made aware, did nothing. Dr. Shah was made aware did nothing. Fast forward to the beginning of 6<sup>th</sup> grade. I watched Amy have my mom arrested, me and my sister humiliated all because she has been taunting us. Once again Dr. Starks aware and Dr. Shah made aware. I have thoughts of harming myself because of anxiety. My Family has not been the same since I told my mom how Amy and Faith mistreated me.

Why is it ok for people that I suppose to feel safe with mistreat me? Why is my mom the villain for just being a mom? My mom can't even get a job because Amy and Felicia lied on her in court, I watched them do it, I was there.
